AIFPA MEMBERSHIP FORMAT

The members of the Association shall be such firms, companies, individuals, organizations, associations, institutions as classified in the manner following, that is to say:

- (a) Ordinary Members being those Indian firms or companies who are
 - (i)engaged in the manufacture, processing, preservation, packaging of food items for human consumption (ii)exporters of food items for human consumption
 - (iii)producers or suppliers of agricultural raw materials for food processing industry for human consumption Ordinary Members may also be called Prime Members.
- (b) <u>Associate Members</u> being those Indian firms or companies who are producers, exporters or suppliers of non-agricultural raw materials, food packaging materials or food processing/preservation/packaging equipment/machinery or are engaged in food service/catering, quality control, training/consultancy, auditing/certification, testing, warehousing, distribution, trading, logistics, publication, information/data services, expos/event organizers in the food sector, other than functions mentioned at Sub-clause(a) above.
- (c) <u>Individual Members</u> being those Indian individuals who by themselves are neither manufacturers nor processors nor exporters nor producers nor suppliers of raw materials/packaging materials/equipment/ machinery to Food Processing/Preservation/Packaging Industry, nor they are traders, distributors, warehousing units, nor firms/companies engaged in food service/catering, quality control, training/ consultancy, auditing/certification, testing, logistics, publication, information/data services, expos/event organizers and are not eligible to be enrolled as Ordinary or Associate Members as per Sub-clauses (a) & (b) above but have otherwise a background in Food Processing/Preservation/Packaging Industry. Individuals working for those firms/companies which are eligible to be covered by Sub-clauses (a) & (b) above cannot become Individual Members unless their firm/company is a member of the Association.
- (d) <u>Honorary Members</u> being persons of exemplary scientific/technical/processing capabilities who have significantly contributed to the improvement and development of Food Processing/Preservation/Packaging Industry in India. Nomination for Honorary Member to be made by the Executive Committee and ratified by the General Body Meeting of the Association.
- (e) <u>Patron Members</u> being persons of national or international eminence who approve of the objects of the Association and are, by virtue of their standing/position, capable of furthering interests of the Association. Nomination for Patron Member to be made by the Executive Committee and ratified by the General Body Meeting of the Association.
- (f) <u>Affiliate Members</u> being those Indian organizations, associations, institutions interested in Food Processing/Preservation/Packaging Industry but who by themselves are not eligible to be enrolled as Ordinary or Associate Members as per Sub-clauses (a) & (b) above.
- (g) <u>Corporate Members</u> being those Ordinary Members covered under Sub-clause (a) above who may become Corporate Member for a fixed period (say twenty years) by paying a one-time membership fee (say Rupees Five Lakh Only). The Executive Committee may recommend to the General Body Meeting to revise the period of such membership and the one-time membership fee to be taken, from time to time, and to charge a small yearly sustenance fee or advertisement from such members.
- (h) <u>International Members</u> being those individuals, firms, companies, organizations, associations, institutions from other countries who are involved in Food Processing/Preservation/Packaging Industry and related activities or are producers/suppliers of raw materials or packaging materials or equipment/machinery or processed foods or are engaged in food service/catering, quality control, training/consultancy, auditing/certification, testing, warehousing, distribution, trading, logistics, publication, information/data services, expos/event organizers in the food sector or are directly interested in Food Processing/ Preservation/Packaging Industry. International Members are not entitled to vote or hold any office in the Association.
